Key Terminology

Daily Supply Charge

Daily Supply Charge is a charge that applies for supplying electricity to your premises for each day of the billing period, regardless of how much electricity you use.

kWh

A 'kWh' stands for kilowatt hour and is the unit of measurement for your electricity bill.

Key Features of This Offer

Contract Term

The contract term for this market offer is for customers who sign up for Monthly contract.

Market Offer

Market Offer - receive 19% discount off the electricity consumption. This offer is applicable if the bill is paid on time (by the date specified on the bill). Where the bill is not paid by the due date, the standard offer rate will be applied.

Direct Debit Discount/Automatic Payments

Direct Debit Discount is a percentage discount applicable to consumption charges only.

Earn an additional 6% discount off your consumption charges by setting up automatic payments from your nominated financial institution.

To be eligible for Direct Debit Discount you must be a Victorian Residential Customer and provide valid direct debit or credit card details to pay your invoice balances automatically on the invoice due date.

Note: We only accept VISA and Mastercard for credit card payments, credit card payments incur a 0.82% merchant surcharge.

Electronic billing

Online bill delivery to email is available. Otherwise, bills can be posted for \$1.00 (\$1.10 GST Inc) per bill.

Fees

Printed bill

Printed bill will incur a fee of a \$1.00 (\$1.10 GST Inc).

Dishonoured Payment

Every declined payment will incur a dishonoured payment fee of \$8.64 (\$9.50 GST Inc).

Disconnection Fee

Every attempt of disconnection (including when you move out) will incur a fee of \$27.16^ (Ex GST). ^Amount is not subjected to GST.

Reconnection Fee

Every attempt of reconnection (including when you move in) will incur a fee of \$26.81^ (Ex GST).

^Amount is not subjected to GST.
